UNDERSTAND AND ACCEPT THE FOLLOWING:**

- I understand that my child may not attend the program until Dalby Farm receives all of the properly completed forms and any and all outstanding payments.
- I understand that the Program Director reserves the right to dismiss a participant if, in her judgment, the participant's behavior interferes with the rights or safety of others, or the smooth functioning of a group or activity, or violates the program's principles of conduct, or if the child has special needs that were not brought to the Program Director's attention at the time of registration.
- Cell phones can be disruptive and take away from the environment that we are attempting to create. Therefore, in order to maximize everyone's 'Experience' while at the farm, Dalby Farm requests that ALL cell phones be left home. If there is a special situation where it is *necessary* for a child to bring one, however, the Program Director should be made aware of the circumstances, so that an appropriate plan can be implemented.
- I authorize Dalby Farm to make, have, use, publish and reproduce photographs, slides and videotapes of my child for Dalby Farm records or public relations purposes.
- I understand that it is my responsibility to bring any special concerns about my child to the Director's attention at the time of Registration.
- I understand that I cannot send my child to Dalby Farm when he/she is ill.
- Depending on the state mandates at the time of the program, it is possible that your child will need to arrive with a mask, which they will be expected to wear as/if needed.
- I give permission for my child to receive first aid treatment as needed and I authorize them to be taken to a doctor or hospital and treated if I cannot be reached in an emergency.

**PARENTAL CONSENT, RELEASE FROM LIABILITY AND INDEMNITY  
AGREEMENT**

I hereby consent to the participant (or caregiver) complying with all of Dalby Farm's safety procedures, which may include temperature checks and answering health questions that relate to symptoms of Coronavirus/COVID-19.

## **The Dalby Farm Experience: Exploring Farm Animals** (For children *entering* K-3rd grade)

'The Dalby Farm Experience': Exploring Farm Animals is an interactive summer learning program for children entering K-3rd grade. Our farm provides an ideal environment for children to 'experience' learning through hands-on farm and animal activities, games and crafts.

Exploring Farm Animals, offers a different theme every day. The presentation, activities, and crafts are designed to reinforce and coincide with the presented subject matter so that the child has fun while learning. Each day of the program covers a different farm animal so that the participant can partake in both sessions without repetition.

Through a curriculum designed for children entering K-3rd grade, 'Exploring Farm Animals' participants will learn about farm animals and their habitats, via stories, hands-on activities and crafts. Being on a farm, the children are able to explore them through their senses. They will hear the rooster crow, feel the softness of sheep's wool and see the rich color and beauty of a chicken's feather.

Each program participant should bring along a trashless boxed lunch and drink. It is also recommended that each child bring a refillable water bottle that can be used throughout the day. Please note: The majority of The Experience takes place outside and each program participant will partake in outdoor activities, walk on wooded trails and will have contact with farm animals. The Experience will be held rain or shine. In the event of inclement weather, program participants should bring appropriate outerwear.

**Exploring Farm Animals is offered to children entering grades K-3 and the program is offered, 9:00 a.m. – 1:00 p.m.**

**2023 Dates: Monday July 17, Wednesday July 19 and Friday July 21.  
Monday July 24, Wednesday July 26 and Friday July 28.**

**Program Fee: \$240.00 per child per session.**

How to register: Registration is on a first come-first serve basis. *Enrollment is extremely limited.* Registrations are accepted by mail. A child is not considered registered until a written confirmation has been sent, via e-mail, by Dalby Farm. The \$100.00 non-refundable registration fee (\$105.00 on line) is included in the total cost of the program. Full payment is due by May 1, 2023. If registering after that date, providing that space is available, the total program fee is due at the time of registration and all forms are due by June 30, 2023.

Refunds will not be given for incomplete attendance. Dalby Farm reserves the right to cancel or combine any program due to under enrollment. Only in the case of the cancellation of the program, a full refund will be given (including enrollment fee). There is a \$35.00 service fee for any returned checks.

Covid 19 Procedures at Dalby Farm: As always, the health and safety of anyone visiting the farm is our number one priority. For all activities being held at the farm, we are following the guidelines set by the Scituate Board of Health and the Massachusetts Department of Public Health. While at Dalby Farm, we request that everyone 3 years and older have a mask, that fits securely, covering both the nose and mouth, to have on hand if needed. As stated, we will practice whatever the state and local board of health mandates at the time of the program. In addition, hand washing throughout the day

will be expected as well. As we navigate through this pandemic, the rules and/or practices may change; we will be sure to keep you updated as soon as any additional information becomes available.
